He indicated council will need to have a future discussion on the traditional camping locations beach side in Port Harmon. The airport has inquired if the town can review limiting campers in Port Harmon beach side area due to the increased presence of birds and the danger it brings to aircrafts. Deputy Mayor encouraged campers to delay setting up as the town will explore other area(s) to designate to campers.

Councillor Aylward

Councillors Aylward as Chair of the Hospital Foundation provided an update. Stating twenty members are on the board and over the past 37 years of fundraising they have raised over three million through online auctions, guardian angel pins, memorial board, tree of love. The office is open every Thursday 1-3 pm. She stated the Sir Thomas Roddick Hospital has a surgeon until August, and they are still recruiting doctors; our hospital has modern equipment, and she is thankful because some communities are not so fortunate.

Mayor Rose

- Reminded residents of Mowi public engagement session tonight for the expansion of the Hatchery.
- World Energy announced the acquisition to purchase the Port of Stephenville. They will be holding community information session in Stephenville on Monday April 24.
- Airport should be sold to Carl Dymond within next 3 weeks.

Coucillor Tiller

Acknowledged and congratulated Ernest & Young, the airport and the town as the airport has been cleared of bankruptcy, he questioned if the town should provide its 30 days' notice to stop payment to the airport given the transaction to transfer the airport can be done in 20 days and the town could potentially provide money to private enterprises. In response Mayor Rose stated, this could be clarified, however in the terms of the sale Dymond has up to 20 days to transfer the funds into trust, and it was the opinion of the mayor that once it's validated the funds will be transferred, the town would provide the notice.

Councillor Boland

She asked for an update on the towns water system, In response CAO stated once the Gas Tax application is approved the redevelopment of three wells # 7, 9,10, will commence and the maintenance of Well No. 8 and No.1. New wells will have to be drilled in the near future and we are continuing to find and fix water leaks.

Deputy Mayor Fowlow

She noted it's important to recognize the town has aging infrastructure, and water main leaks will happen, It's important that we be prepared for growth and asset management of the water system is important.

Line painting is on track to commence soon.
